 - i. Framework (MPE → MPA) (2015-2016)
 - 1. legal framework limiting the delegation
 - 2. Before delegation clear definition MPE task/responsibility
 - 3. Staffing guidelines
 - 4. Registration of CME for MPAs
 - ii. New BSS (by FANC/AFCN) has an impact on the mentioned part
 - iii. Transition to professional workgroup (on short notice), feedback were given also for three domains (RX,NM,RT) to find common ground (for the Royal decree discussion FANC)

- b. NM (P. Merlo):
 - i. Active participation of various tasks
 - ii. Low-dose CT in NM
 - iii. QC (well counter)
 - iv. Contribution to Royal decree to comment to FANC
- c. RX (H. Bosmans):
 - i. Protocols for testing systems (Angiocardiac system, CBCT) WP, first draft of the recommendation expected Sumer
 - ii. CME last year: January and September
 - iii. CME this year: 6th May and December
 - iv. Contribution to Royal decree to comment to FANC
- d. RT-24:
 - i. First meeting was in December: mainly to discuss/comment on Royal decree (FANC)
 - ii. FANC proposed staffing level (RP 174)
 - iii. Inspection campaign for RT 2015-2016
 - 1. Strong recommendation to make formalize commissioning (e.g. technique, signed by head of department as well)
 - iv. CE for RT this year probably: Adaptive/Automated planning, while Protontherapy might follow next year
 - v. ABRO-BVRO Task Force on staff (Nadine, Jan)
 - Outdated levels (1991 / 2005) other adaptation can be addressed (Nomenclature, Revision of BSS, ESTRO-HERO)
 - 2. General revision asked by the Minister (not only RT and MPE)
 - 3. First meeting (Nov 2016):
 - a. Estimation of required MPE (based on RP 174) RTTs needs to come up with their numbers)
 - 4. Second meeting (Dec 2016):
 - a. Medical imagers can work legally probably at RT from July 2017 probably
 - b. Minimal / optimal staffing level with careful evaluation of current situation (e.g. satellites)
 - c. 14 file were completed and provided, further reply are expected
 - d. [FVH comment:] Current situation: Several centers already report on overhours needed to maintain clinical routine not even to commit to further techniques/commissioning
 - e. [GP comment:] Number of medical physicist are not increasing as it was 15-20 years ago
 - f. Next RT-24 meeting is expected in May 2017
- e. NCS report (Alex):
 - i. Various NCS reports are in preparation (slice), majority of them with Belgian contribution
 - ii. Active members / contributors are expected:
 - 1. Stereotactic SBRT
