Professional Matters

Commission Paritaire/Paritair Comité 330



- Potential confusion: function of “fysicus/physicien” en “diensthoofd fysicus/chef physicien” defined
- But: described functions are only applicable to RT, not NM or RX, and description of “chef” is not appropriate for the head of the soon-to-be internal MPS...
- “Institute for function classification” IC-IF, written by “sector and social partners”
- BHPA of FANC not involved
- Can only be changed by invoking a “onderhoudsprocedure/Procédure d’entretien” by “social partners” (?)
- Juridical department of FANC: no official reaction, “not our domain”
- BHPA action?



New legislation

28th of september 2017: stakeholders meeting with MD's, companies, MPE, RTT's of NM, RX and RT to discuss 1st draft

On September 10th, BHPA gave a written list of remarks after a meeting in Leuven with many representatives of MPE of all 3 disciplines.

Publication is delayed because of need to first revise the FANC law. After this the draft of new legislation then needs to pass through the legal checks of the FANC. Final publication is expected in February 2019...

Major point: creation of hospital level MPS: already defined in FANC law which has passed the "ministerraad", has passed the "raad van state", and is now back at the "ministerraad" for some minor formatting changes.

Points of discussion

for RT: 60% MPE versus 40% MPA as minimal... BHPA point of view?

For NM: defining the level of intervention, hybrid imaging, radionuclide dosimetry

→ BHPA should take initiative to talk to industry about QC and responsibilities

For RX:

Taskforce new norms in RT

Taskforce new norms in RT



- WHAT? Revision of old norms in RT dating from 1991 (slightly) revised in 2005
- WHY? Outdated: New techniques ? New professions ?
- WHO? ABRO-BVRO / GBS-VBS / College of Radiotherapy/ VVRO / AFITER / **BHPA** / FANC

STATUS:

- “Evidence based” staffing and equipment levels: HERO (ESTRO) model (ABC) → WIP (stress test,...)
- BHPA model to define staffing of MPS (= MPA + MPE): converging towards agreement (see RT-24 for more details)
- First draft expected within couple of months:

Will define the norms to perform safe and up to date RT:

Irradiation Unit, Proton, cobalt / contact / simulator (CT), Brachy, Measuring equipment, MLC / Individualized blocks), Therapy file, Medical file, Medical staffing, Head of department, physics staffing (head of RT physics +MPE+MPA = MPS in RT), Quality Manager, RTT's, Education,...
